Artists should keep in mind that their works should be appropriate for public display and will be evaluated for acceptance based on renderings that are appropriate to the Angel theme and the spirit of the holiday. They need not reflect a Christmas theme, but they should be angelic in nature. Corporate logos and advertising are not allowed. The review panel may reject any design or work that, in its sole discretion, does not adhere to these guidelines and the spirit of the occasion. Factors such as size and weight appropriate to the exhibit venues will also be a consideration. This project is open to all artists and not limited to local work. No more than three different designs may be submitted by an artist.

- **Proposal Submission Process:** Please submit a non-returnable proposal (*not to exceed two 8 ½ X 11” pages*) that includes a brief description of yourself, a sketch or depiction of your design as well as a written description, dimensions and materials of the artwork, to the ESAC. The proposals will be included in a notebook for perusal by potential sponsors. Please note that the more complete your description and design, the easier it will be for the review panel and prospective sponsors to evaluate your submission. Also note that all application materials become the property of Calling All Angels and will not be returned to the artists. Please make a copy of your proposal/application for your records.
- **Sponsorship:** artists will be notified immediately upon receiving sponsorship.
- **Juried Show:** to be considered in the juried show, a digital/photographic representation of your finished Calling All Angels artwork must be submitted by **October 30, 2008** to the ESAC or by e-mail to [info@mercymedical.com](mailto:info@mercymedical.com).
- **Artwork Delivery:** Artwork must be completed, dried, properly equipped for hanging, and gallery wrapped or framed (no staples showing) and delivered on 11/3/08, between 9 am to 4 pm to the ESAC. Arrangements must be made prior to 10/27/08 for other accommodations of delivery. Artwork requires identification including artist name, title, medium, and phone number.
- **Proceeds from Calling All Angels:** benefits the Eastern Shore Art Association, a nonprofit organization. (Federal Tax ID 63-0459459) and Mercy Medical, a non-profit 501 (c)3 organization (Federal Tax ID #63-6002215) Selected artists may receive a percentage of the amount the artwork brings at the Auction.
